

SMARTDRAW TERMS OF SERVICE

Welcome to the online edition of SmartDraw, which is maintained and operated by SmartDraw Software, LLC (the “Company”).

These SMARTDRAW TERMS OF SERVICE (the “Terms”) are entered into by and between the applicable person or legal entity accessing or using SmartDraw (“you” or “your”) and the Company, and govern your access to and use of SmartDraw (including without limitation any content, functionality, and services offered or made available through or using SmartDraw). For avoidance of doubt, the terms “you” and “your” when used in these Terms shall mean both the License Purchaser and each User. Capitalized terms used and not defined elsewhere in these Terms will have the meaning set forth for such terms in the “Definitions” section below.

Please carefully read these terms before using SmartDraw. The Company will allow access to and use of SmartDraw only upon the condition that you accept and agree to be bound by and abide by these Terms and our Privacy Policy found at <https://www.smartdraw.com/about/privacy.htm> (as amended from time to time, the “Privacy Policy”), the terms of which are incorporated herein by reference. By your access or use of SmartDraw, you are accepting and agreeing to be legally bound by these Terms. Before you continue, you should print or save a local copy of these terms for your records. If you are agreeing to these terms on behalf of a company or other legal entity, you represent and warrant that you have the legal authority to bind such entity to these terms, and all reference to “you” or “your” shall apply to such entity. IF YOU DO NOT HAVE SUCH AUTHORITY, IF YOU DO NOT AGREE TO BE BOUND BY THESE Terms OR THE Privacy Policy, OR IF YOU CANNOT MAKE ANY OF THE REPRESENTATIONS, WARRANTIES, OR COVENANTS SET FORTH IN THESE Terms, THEN DO NOT USE OR ACCESS SmartDraw. THE RIGHT TO ACCESS AND USE SmartDraw IS AGE RESTRICTED, IF YOU ARE UNDER 18 YEARS OF AGE YOU MAY NOT USE SmartDraw. BY AGREEING TO THESE Terms, YOU ARE REPRESENTING AND WARRANTING TO THE Company THAT YOU ARE OVER 18 YEARS OF AGE.

We reserve the right to change or modify these Terms at any time and for any reason in our sole discretion. If we make changes to the Terms, we will provide you with notice of such changes by updating the “Last Modified” date at the beginning of these Terms. Continuing to access or use SmartDraw following any such update shall constitute your acceptance of, and agreement to be bound by, the revised Terms. We encourage you to review the Terms frequently to ensure that you understand the terms and conditions that apply when you access or use SmartDraw. If you do not agree to the revised Terms, you may no longer access or use SmartDraw. If you have any questions about the Terms, contact us our customer service department in accordance with the instructions on our website (www.smartdraw.com).

Definitions

In addition to capitalized terms defined elsewhere in these Terms, the following capitalized terms will have the meaning provided for such terms below when used in these Terms:

“Authorized Number of Users” means the number of Users who may be provided access to SmartDraw, which such amount shall be: (a) for a License Purchaser, the number of Users indicated on the invoice paid by such License Purchaser for SmartDraw (which may be depicted by the quantity of licenses purchased or otherwise acquired by the License Purchaser); or (b) for any person that is accessing SmartDraw that is not a License Purchaser, only one User (which such User shall be you, the individual, only).

“Beta Period” means the period of time during which Beta Software is made available by the Company to the License Purchaser and/or one or more Users at the sole discretion of the Company.

“Beta Software” means software services, applications, features, functionalities, and any adaptations of, add-ons, or revisions to SmartDraw (or any portion thereof) that: (a) is clearly marked with a "Beta" label; or (b) is offered or made available by the Company to the License Purchaser and/or one or more of its Users free of charge or on a trial, alpha, beta, evaluation, testing, and/or early access basis.

“Content” means diagrams, documents and other information created by you on, or uploaded by you to, the Company’s servers or servers otherwise under the Company’s control or possession, provided, however, that the term Content does not include any Feedback.

“Contextual Click” means a right-click on Devices running Windows, a ctrl-click or secondary click on Apple computers, and a long tap on touch screen Devices.

“Device” means (a) computers, including desktop or laptop computers, used for general computing functions (such as, but not limited to, word processing, e-mail, general purpose internet browsing and office suite productivity tools), (b) smartphones, tablets or other forms of mobile computing devices that permit the running of a web browser, and (c) any other devices pursuant to which you are able to access or use SmartDraw.

“Feedback” means any and all feedback, suggestions, ideas, areas for improvement, requests for features, requests for functionality, requests for reports, or other information regarding the operations, features, functions, processes, or details provided by you or any of your employees, agents, or affiliates to the Company or its agents with respect to SmartDraw or any ancillary or related technologies.

“License Purchaser” means the person or entity, if any, that purchases the applicable License as shown on the corresponding invoice for SmartDraw, provided, however, that if such invoice reflects both an individual name and an entity name, the entity will be deemed the License Purchaser.

“Malware” means viruses, worms, time bombs, trojan horses, spyware and any and all other harmful or malicious code, files, scripts, agents or programs.

“SmartDraw” means the online software service offered by the Company, including without limitation the application, functionality, and features thereof (which includes without limitation

Content storage on the Company's servers and, if applicable, the Beta Software), and any updates, modifications, or error corrections thereto provided by the Company.

"Subscription Term" means: (a) the period of time for which License Purchaser purchased or otherwise acquired a license to access SmartDraw as indicated on the invoice for SmartDraw, which such period shall begin on the start date indicated on the invoice, or (b) for each person accessing SmartDraw that is not a License Purchaser or a User of a License Purchaser, seven (7) days beginning on the date on which access is first granted to you, unless extended by the Company. For the avoidance of doubt, Subscription Term also includes any renewal period (or automatic renewal period) applicable pursuant to these Terms.

"User" means: (a) an individual who is allowed access to SmartDraw by the License Purchaser; or, (b) if there is no License Purchaser, User means you.

License

Subject to these Terms, the Company grants to you a nonexclusive, nontransferable, non-sublicensable, revocable, limited license to access and use SmartDraw (the "License"), provided, however, that such License shall be limited to those forms of use of SmartDraw readily and intentionally provided by the Company through its website. You are solely responsible for obtaining any subscription or connectivity services, software, Devices, or other equipment necessary to access or use SmartDraw and for the payment of all third party fees associated therewith.

SmartDraw may be accessed from any number of Devices, but the License Purchaser may not (or if there is no License Purchaser, you may not) provide access to SmartDraw to a number of Users in excess of the Authorized Number of Users. **THIS IS NOT A CONCURRENT USER LICENSE.** The Authorized Number of Users includes each User that at any time is or has been given access to SmartDraw, regardless of whether such User is accessing SmartDraw at a particular point in time. The Company reserves the right to include one or more watermarks to graphics created with SmartDraw and you will not remove or modify any such watermarks without the Company's prior written consent. License Purchaser will not permit any persons to share User accounts (and you will not share your User account with any Person), and each natural person with access to SmartDraw pursuant to the License purchased by License Purchaser (or which you have if there is no License Purchaser) must have his or her own User account. SmartDraw may only be used for License Purchaser's (or your) personal use, and License Purchaser will allow its Users to access SmartDraw only for this purpose.

To access and use SmartDraw or certain features thereof, you will be asked to provide certain registration details and other information to create a User account and obtain login credentials. It is a condition of the License and your use of SmartDraw that all information you provide to the Company (through the Company's website or otherwise) is correct, current, and complete, and as such you: (a) represent and warrant that all information that you provide to the Company, including without limitation when registering as a User or through a User account, is correct, current, and complete as of the time it is provided; and (b) will promptly (and in any case, within five business days) update such information if such information for any reason becomes, or you discover any

such information to be, incorrect, inaccurate, or incomplete.

License Purchaser represents, warrants, and covenants (or if there is no License Purchaser, you represent, warrant, and covenant) to the Company that: (a) if an entity, it is, and throughout the Subscription Term will remain, properly registered, validly existing, and in good standing under the laws of the state where its principal office is located; (b) it and each of its Users has full authority and power to enter into these Terms and perform its obligations hereunder; (c) entering into and performing these Terms, and its and its Users' access and use of SmartDraw, will not violate any law, regulation, or other agreement by which License Purchaser or any of its Users is subject or bound; and (d) it has the power and authority to enter into these Terms on behalf of each of its Users and to bind its Users to the terms set forth herein.

Term and Termination

Subject to these Terms, the License will last for the Subscription Term unless earlier terminated by the Company in accordance with these Terms. You acknowledge that (i) your right to access and use SmartDraw is limited to the term of the License Purchaser's Subscription Term or a shorter period of time if the License is terminated prior to the end of the Subscription Term pursuant to these Terms (or if there is no License Purchaser, the applicable Subscription Term unless earlier terminated by Company in accordance with these Terms), (ii) access to SmartDraw will cease upon the earlier of termination of the License or expiration of the Subscription Term if the subscription is not renewed, and (iii) although the License Purchaser (or, if applicable, you) may elect to renew the License, the terms upon which access to and use of SmartDraw may be licensed upon a renewal are subject to change by the Company, in its sole discretion.

Notwithstanding the foregoing, the License with respect to the Beta Software will only be in effect for the Beta Period. As such, the Beta Software is offered by the Company to License Purchaser and/or one or more of its Users solely on an optional and temporary basis during the Beta Period, and the Company may at its sole discretion discontinue or terminate any or all access to and use of Beta Software by the License Purchaser and/or one or more of its Users at any time, for any reason, and without prior notice. You hereby acknowledge and agree that the Beta Period may be shorter than the remainder of the Subscription Term.

Upon the earlier of expiration of the Subscription Term or termination of the License in accordance with these Terms, the Company shall have no obligation to maintain or provide access to any of your Content resident on the Company's servers or servers under the Company's control or possession, and the Company may at its discretion thereafter, unless legally prohibited, delete all of your Content resident on the Company's servers or servers under the Company's control or possession. With respect to any Content that is stored, created, provided, or managed utilizing the Beta Services, the Company may in its sole discretion remove or destroy any such Content upon the conclusion of the Beta Period and will have no obligation to maintain or provide you with any access to any such Content following the conclusion of the Beta Period.

The Company may, in its sole discretion, terminate the License prior to the expiration of the Subscription Term if: (a) you, License Purchaser, or any User violates these Terms; (b) the License Purchaser fails to pay any amount due or owing to the Company pursuant to these Terms or the

amount set forth in the applicable invoice for SmartDraw, including without limitation in the event of any declined payment, chargeback, bounced check, ACH reject, or any other event in which any payment made by or on behalf of License Purchaser is reversed or not fulfilled; or (c) there is any unauthorized access or use of SmartDraw. Notwithstanding the foregoing, the Company may terminate the License with respect to any Beta Software (and cease making the Beta Software available, in whole or in part) at any time and for any reason, in Company's sole discretion.

License Purchaser may terminate any of its User's access to SmartDraw under the License granted to License Purchaser at any time, either through the administrative user functionality made available to License Purchaser in SmartDraw or by notifying the Company's customer service department (provided that if a User's access is terminated by License Purchaser by notifying Company's customer service department, such termination will not be effective until the Company receives and has a reasonable period to act on such notification).

If the Company reasonably suspects License Purchaser or any User of violating these Terms, reasonably believes the account of License Purchaser or a User has been compromised, or reasonably believes you are using SmartDraw for a non-authorized or illegal purpose, the Company may suspend your access to SmartDraw while investigating such circumstances.

Your right to access and use SmartDraw shall automatically terminate upon any termination or expiration of the License, provided however, that your right to access and use the Beta Software shall terminate upon the conclusion of the Beta Period. Termination or expiration of the License (in whole or in part) will not relieve you from, and you will remain responsible for, all liabilities and obligations arising prior to (or from acts, omissions, or events occurring prior to) such termination or expiration.

Unless otherwise set forth on the invoice for SmartDraw that was paid by License Purchaser, if any, all payments and subscriptions to SmartDraw are non-refundable and the Company will have no obligation to repay or return any portion thereof under any circumstances, even if there are periods of unavailability, if changes in your circumstances result in you not using (or not being able to use) SmartDraw or any portion thereof, SmartDraw or any portion thereof fails to fulfill your expectations, modifications to SmartDraw or any portion thereof result in it not being usable or practical for your use case, any Beta Period expires, or the License is terminated (in whole or in part) prior to the expiration date thereof for any reason.

Automatic Renewal

Unless the License Purchaser has cancelled the autorenewal in accordance herewith, the License will automatically be renewed upon expiration of the Subscription Term using the contact and billing information provided at the time of the initial purchase of the License. The License Purchaser may cancel the automatic renewal of the License by: (a) visiting the "My Account" page accessible after logging into SmartDraw and selecting the option to cancel automatic renewal of the License at any time prior to such automatic renewal; or (b) contacting the Company's customer support (see <https://www.smartdraw.com/support/>) and informing the Company of License Purchaser's election to cancel the automatic renewal (together with sufficient information for the Company to identify the applicable License Purchaser) at least five business days a prior to such

automatic renewal.

If the License Purchaser does not notify the Company of updates to the License Purchaser's payment method, to avoid interruption of your service, the Company may participate in programs supported by the License Purchaser's card provider to try to update such payment information, and the License Purchaser authorizes the Company to continue billing the License Purchaser's account with the updated information that the Company so obtains.

If the License Purchaser does not elect to renew the License, upon termination thereof, at the election of the Company: (a) each User of License Purchaser will be converted into an individual User; or (b) Company may terminate all access to SmartDraw by each User of License Purchaser and remove all Content provided, uploaded, created, or otherwise saved by each such User.

Use of SmartDraw

The License Purchaser is responsible for (or if there is no License Purchaser, you are responsible for): (a) its Users' compliance with these Terms; (b) identifying and authenticating all of its Users; (c) approving access by such Users to SmartDraw under the License; (d) preventing unauthorized access or use of SmartDraw by Users or any person or entity using any credentials of License Purchaser or any User thereof; (e) all activities that occur under its Users' usernames, passwords, accounts, or other credentials or as a result of its or the Users' access or use of SmartDraw; and (f) maintaining the confidentiality of its and its Users' usernames, passwords, account information, and all other credentials (including without limitation those for, applicable to, or used in connection with SmartDraw). By allowing access to SmartDraw to Users, the License Purchaser accepts (or, if no License Purchaser, you accept) responsibility for the confidentiality and timely and proper termination of User records, accounts, and credentials. The Company is not responsible for any harm caused by you, License Purchaser, or any of your or License Purchaser's Users or any person accessing a User account, including without limitation individuals who were not authorized to have access to SmartDraw but were able to gain access because usernames, passwords, accounts, or other credentials were not terminated by you or License Purchaser on a timely basis or were not kept confidential. The License Purchaser or you will notify the Company immediately of any unauthorized access or use of SmartDraw, and Company may immediately and without notice suspend any accounts that are, or are reasonably believed, to be compromised. A License Purchaser may designate a person (the "License Administrator") to administer the functions described above, but the License Purchaser will remain ultimately responsible for compliance with these Terms. Company will be entitled to rely on all information, requests, changes, modifications, directions, and instructions provided to Company by you or the License Administrator.

The Company may make certain administrative functionality available to the User account for the License Administrator, which may include without limitation the ability to: (i) create, enable, disable, restrict, or otherwise administer User accounts within the License granted to License Purchaser; (ii) access and modify account settings for User accounts within the License granted to License Purchaser, including without limitation changing the email address, name, username, password, or other credentials associated with such User accounts; and (iii) access, review, modify, transfer, share, control, or delete Content, settings, communications, or other account functions

associated with such User accounts. License Purchaser will be solely responsible and liable for (and Company will have no responsibility or liability for) any and all actions taken by the License Administrator or which are taken utilizing the License Administrator's User account and for all management of each of the Users falling under the License granted to License Purchaser. The License Administrator will only use its User account for purposes of managing the User accounts available pursuant to the License granted to License Purchaser and will be responsible for all management of such User accounts (including without limitation closing or disabling such User accounts to prevent unauthorized access or use following the termination of any User).

Content

The Company does not claim any intellectual property rights in any Content created by Users using SmartDraw under the License, and nothing in these Terms is intended to grant the Company any rights to your Content or intellectual property therein except for the limited rights set forth below (which such rights are generally required by the Company to operate or improve SmartDraw, as explained below), or to the extent you elect to use Images (defined below) or incorporate Images into the Content, in which case the licenses applicable to the Images (as set forth below) shall apply solely with respect to the Images. **Each User hereby agrees that for all purposes under this License, the Company shall be entitled to treat the License Purchaser (or if no License Purchaser, you) as the full and sole owner of any and all intellectual property rights in Content uploaded, submitted, created, or transmitted by or at the direction of any User, and License Purchaser represents and warrants (or if no License Purchaser, you represent and warrant) that it is (or you are) the full and sole owner of (or has and will at all times maintain a valid license to use, in the manner used) any and all intellectual property rights in or to the Content.**

By creating, uploading or otherwise submitting Content to SmartDraw, you grant the Company permission to take any and all actions required to make SmartDraw available and functional or to improve SmartDraw, including without limitation: (a) processing and displaying such Content, or any portion thereof, in accordance with your instructions or consistent with your use of SmartDraw; (b) hosting your Content on the Company's servers or servers under the Company's control or possession; (c) sharing your Content at your direction; (d) internally evaluating your interaction, use, or modification of the Content for purposes of testing or benchmarking SmartDraw or improving SmartDraw (including without limitation the development by Company of new features, functions, processes, methods, or procedures); (e) making available product features visible to you, for example, image thumbnails or document previews; (f) for design choices the Company makes to administer SmartDraw technically; and (g) to redundantly backup data in accordance with the Company's data retention and management policies and procedures.

If any Content is reported to the Company as violating these Terms, infringing a third party's intellectual property rights, or otherwise being objectionable, the Company reserves the right to, at any time and in its sole discretion without notice, remove your Content and/or prohibit you from using SmartDraw. You should not rely on SmartDraw to store any data or information and you should maintain backups and copies of all of your data and information. The Company will not be liable or responsible for any loss or damages you suffer as a result of your Content being removed and/or deleted.

Sharing and Managing Content and Communications

SmartDraw provides features that allow you to share your Content with others. Content that you share with others from SmartDraw could become available to unanticipated third parties or to the public at large should that link be made available to such third parties or otherwise become public (including without limitation due to such link being shared by the original recipient). Please consider carefully what Content you choose to share and with whom you share it. There are many things that recipients may do with Content you share (for example, copy it, modify it, re-share it). The Company has no responsibility or obligation to supervise or monitor the use by others of your Content, or to assist you in enforcing the terms of any permissions, rights or licenses you may grant to those with whom you choose to share Content.

Notwithstanding anything to the contrary herein, you are solely responsible for your conduct, your Content and your communications with others while using SmartDraw, including without limitation any and all conduct, Content, and communications shared or submitted to, through, or using SmartDraw. You represent, warrant and covenant to Company that, at all times you have all rights, authority, and permission necessary or appropriate to (a) comply with these Terms; (b) upload, use, modify, edit, display, and share any and all Content in the manner in which you engage in such activities through or using SmartDraw; (c) to disclose the Content that is communicated with, through, or using SmartDraw, including without limitation all Content shared with third parties and all data and information you send or make available to others via or through SmartDraw. The Company has no obligation to monitor any information on SmartDraw and you represent and warrant that your Content and your use and sharing thereof does not and will not infringe on the intellectual property rights or other proprietary rights of any third party. You are solely responsible (and the Company is not in any manner responsible) for the accuracy, completeness, appropriateness, or legality of Content you upload, provide, share, access or use through SmartDraw.

Your Use of SmartDraw

Content in SmartDraw may be protected by intellectual property rights of others. You agree to not create, copy, upload, download or import to, or share any Content on or using, SmartDraw: (a) that would infringe on the intellectual property rights or other proprietary rights of any other person or entity; and (b) unless you have all necessary and appropriate rights, permissions, and authority to engage in such activity. You are fully responsible and liable for what you create, copy, share, upload, download, import or otherwise employ while using SmartDraw, and the Company will have no responsibility of any type for such use. You must not upload Malware to SmartDraw or access or use any SmartDraw systems or resources for anything other than the functionality explicitly made available to you by the Company.

If your contact information or other information related to your account changes, you must promptly (and in any event, within five days of such change) notify the Company of such change by: (a) updating your contact information or other information related to your account through the “My Account” option on the Company’s website (available after you log in); or (b) contacting the Company’s customer service department and providing the customer service department with the

updated information as well as sufficient information to identify you and confirm your identity. You are responsible for safeguarding the password that you (and in the case of the License Purchaser, that each of your Users) use to access SmartDraw and you agree to take all measures necessary or appropriate to prevent the unauthorized disclosure or use of your username, password, account information, or other credentials associated with SmartDraw. You are responsible for any activity that occurs using your account (or in the case of a License Purchaser, any activity that occurs using any of your Users accounts) whether or not you authorized that activity. You agree to immediately notify the Company of any unauthorized access or use of your account.

You agree that you will not misuse SmartDraw. Whether you have engaged in the misuse of SmartDraw will be determined by the Company in its reasonable discretion on a case-by-case basis, however, without limiting the generality of the foregoing, all of the following situations shall constitute cases of misuse: (a) if you interfere with SmartDraw or try to access or use SmartDraw using a method other than the interface and instructions the Company provides; (b) any failure by you (or if you are the License Purchaser, your Users) to abide by the Company's Acceptable Use Policy or the Company's General Restrictions (each as set forth below in these Terms); (c) the infringement on or misappropriation of any third party's intellectual property rights or other proprietary rights through or as a result of your Content or use of SmartDraw; (d) your use of SmartDraw in violation of any applicable law or regulation (including without limitation the improper import or export of any data or information as a result of your Content, sharing, or communications on or using SmartDraw); and (e) unauthorized sharing of user names, passwords, other credentials, or accounts or otherwise in any manner bypassing or circumventing the Authorized Number of Users.

Beta Software Confidentiality

All Beta Software and all information disclosed or provided by the Company in connection with Beta Software, including the availability of Beta Software, as well as its performance data and metrics (collectively "Confidential Information") constitutes confidential information of the Company and you agree: (a) not to disclose Confidential Information to any third party; (b) not to use the Confidential Information except in connection with your own personal use of SmartDraw as expressly authorized and permitted under the License; and (c) to use the same degree of care to protect such Confidential Information that you use to protect the confidentiality of your own confidential information, but in no event less than reasonable care.

Cookies

SmartDraw may use Cookies. "Cookies" are small pieces of information that are stored by your browser on your Device that, among other functions, allow SmartDraw to be customized or tailored on an individual basis (including without limitation storing and providing certain identifying information and potentially user preferences, settings, history, access information, credentials, passwords, and other information). Cookies can be useful to you by saving and retrieving passwords and other information and preferences you use on SmartDraw, and may save you from having to re-enter certain information every time you visit SmartDraw. Please be aware that Cookies may also be received when you link to another website from SmartDraw and we do not have control over how they use this information. Cookies can also enable us to track and target

the interests and use of Users to enhance the experience with SmartDraw. Most web browsers automatically accept Cookies, but if you prefer, you can edit your browser options to block them in the future. Please be aware that, if you elect not to accept Cookies, some of the features of SmartDraw may not function properly and your access to or use of SmartDraw may be more cumbersome and less efficient, or may fail to work altogether. You will be solely responsible for your decision to accept or reject Cookies, and any unavailability or non-functioning of SmartDraw (or any portions thereof) that results from your decision will not constitute unavailability, non-performance, or any other failure, of any nature, by the Company.

Intellectual Property Matters

Use of SmartDraw does not give you ownership of any intellectual property rights in SmartDraw or any Content that is not your own. SmartDraw and the technologies the Company uses to provide SmartDraw are the sole and exclusive property of Company and its licensors and are protected by patent, copyright, trademark, and other laws of both the United States and foreign countries. Your only interest in SmartDraw is the License and nothing herein grants you (and you shall not accrue in any manner) any other right, title, or interest in or to SmartDraw, the intellectual property rights associated with SmartDraw, or any third party's data or other Content. These Terms do not grant you any rights to use the Company's trademarks, logos, domain names, or other brand features. All rights of every kind that are not expressly granted to you in these Terms are entirely and exclusively reserved by the Company and its licensors.

All right, title, and interest in and to all Feedback is hereby transferred and conveyed by you to Company and shall be owned exclusively by the Company. The Company may (but will not be obligated to) use, implement, apply, incorporate, or otherwise avail itself of any and all Feedback, in whole or in part, at any time and in its sole discretion, and the Company will not have any liability, cost, expense, or other obligation to you or any of your employees, agents, or affiliates with respect thereto.

Acceptable Use Policy

Your authorized access and use of SmartDraw is limited to accessing and using SmartDraw in accordance with these Terms only using the interface, instructions, and functionality that the Company provides. You will not permit any person under the age of 18 to be a User, or if you are under the age of 18, you may not access or use SmartDraw. You expressly agree that: (a) any dispute, claim, controversy, action, or proceeding with or involving the Company is personal to you; (b) any dispute, claim, controversy, action, or proceeding shall only be resolved by arbitration in accordance with these terms (except as otherwise expressly permitted in these Terms) in your individual capacity and not as a plaintiff or class action member in any purported class or representative proceeding; (c) you will not bring a

dispute as a representative of any other person or persons; and (d) you will not permit a dispute to be brought as, and shall not participate in, a class or representative action on behalf of any other person or persons. Except as otherwise expressly set forth in these Terms, a dispute, claim, controversy, action, or proceeding may only be resolved through an individual arbitration proceeding in accordance herewith and shall not be brought as a class arbitration, a class action, or any other representative proceeding.

Other Legal Matters

These Terms shall be governed by and construed in accordance with the laws of the State of Texas, U.S.A., without reference to or application of choice of law rules or principles.

Notwithstanding any choice of law provision or otherwise, the Uniform Computer Information Transactions Act and the United Nations Convention on the international Sale of Goods shall not apply to these Terms. These Terms control the relationship between the Company and you. These Terms do not create any third party beneficiary rights, other than the right of Company to enforce the terms hereof against Users.

License Purchaser and, if different, you, will each: (a) ensure that all of the obligations and terms applicable to Users set forth in these Terms (as may be amended from time to time in accordance herewith) will be binding upon and applicable to each of its Users; (b) be responsible for all acts and omissions of each of its Users, including without limitation any breach by any User of any obligations applicable to such User pursuant to these Terms; and (c) assist and cooperate with the Company, as may be requested by the Company, to protect or enforce the rights or interests of the Company hereunder.

If you do not comply with these Terms, and the Company does not take action right away, this does not mean that the Company is waiving or giving up any rights that it may have (such as taking action in the future). Any waiver by the Company, to be valid, must be in a writing duly executed by the Company, and any waiver of any right by the Company will not preclude any further exercise of that right.

The invalidity or unenforceability of any provision of these Terms shall not affect the validity or enforceability of any other provision of these Terms. If any provision of these Terms or portion thereof shall be held invalid or unenforceable in part, such provision or portion thereof, as applicable, shall be interpreted and substituted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the portion of such provision, together with all other provisions of these Terms, shall remain valid and enforceable and continue in full force and effect to the fullest extent consistent with law.

The English language version of these Terms is legally binding, and in the event of any inconsistencies between the English version and any translations hereof, the English version shall control. The section headings provided in these Terms are for reference purposes only and shall not affect in any way the meaning or interpretation of these Terms. The words herein, hereto, hereof, and words of similar import refer to these Terms as a whole and not to any particular section of these Terms. All instances of the words include, includes, or including in these Terms

shall be deemed to be followed by “without limitation” unless already followed by such words or words of substantially the same meaning. The word “or” when used herein shall not be limited and shall mean the conjunctive “and/or”.

Company may, is expressly permitted to, and will not be deemed to be in breach of any obligation of these Terms if it elects to: (i) update, modify, or adjust any security, data security, or backup processes, procedures, protections, methods, controls, or measures, including without limitation adopting or implementing additional or stronger security processes or controls; (ii) update, modify, change, or adjust SmartDraw or any of the functionality, services, processes, procedures, interface, access methods, software, systems, or other aspects thereof, in whole or in part, including without limitation implementing new features, addressing errors, fixing bugs, and otherwise improving or modifying SmartDraw; (iii) update its Privacy Policy in accordance with its terms, which such updated Privacy Policy will be effective upon the applicable update; (iv) update its Acceptable Use Policy or General Restrictions, which such updates shall be effective upon notice to License Purchaser thereof; and (v) make any other modifications to SmartDraw or these Terms as may be necessary or appropriate to comply with any applicable law or regulation, which such modifications will be effective upon posting of such update.

Except as expressly set forth in this Agreement, all rights and remedies conferred herein shall be cumulative and in addition to all other rights and remedies available to each party.

Certain Taxes

You, and if different than you, License Purchaser are each responsible for paying, and will pay, any and all taxes due and owing as a result of the License or the other transactions contemplated hereby (other than taxes owed by Company on Company’s income resulting from this Agreement, if any). If you or the License Purchaser is subject to the Value Added Tax (“VAT”) within the European Union or the Goods and Services Tax (“GST”) within Australia, and has provided the Company with an exemption identification number to avoid collection of the tax in connection with the purchase of the License, you or the License Purchaser is deemed for all purposes to have represented and warranted to the Company that it holds a valid exemption from the VAT or GST, as applicable. The License Purchaser and you will each indemnify and hold harmless the Company for any claims against the Company resulting from a breach of this representation and warranty by the you or the License Purchaser.

Assignment

Your rights hereunder are not assignable, sublicensable or transferable without the prior written consent of the Company, which consent may be provided or withheld on a case-by-case basis in the Company’s sole discretion. The Company may freely assign, transfer, and delegate its rights and obligations under this Agreement at any time and for any reason.

Notices; User Communications

You agree to keep on-file with the Company, at all times, a valid email address and mailing address, in each case that you regularly monitor. If you change your email or mailing address, you

agree to promptly (and in any event within three days) update the email address then on-file with the Company, either through appropriate section of the “My Account” menu when logged into SmartDraw or by notifying the Company’s customer service department (see the “contact us” link available at <https://www.smartdraw.com/support/>) and providing the customer service department with the updated information as well as sufficient information to identify you and verify your identity. You agree that any and all notices to be provided to you by Company may be provided, at the Company’s discretion: (a) through posting an account alert, notice, or message via the SmartDraw platform, which such notice will be deemed effective upon posting; (b) by sending such notice via email to your email address then on-file with the Company, which such notice shall be deemed effective upon sending such email; or (c) by sending such notice to your mailing address, either by US Postal Service or overnight courier, in each case postage prepaid, which such notice shall be deemed effective three (3) days after being sent if sent by US Postal Service or the day after being sent if sent by overnight courier.
